It was determined upon closer inspection that the sample resolution provided to the member agencies by the Director was not sufficient to complete the process for admission as a member since it lacked the actual amendment to the original JPA Agreement. Additionally, the Apple Valley Fire Protection District has subsequently requested membership to the JPA.

It is necessary to revise the sample resolution for the amended JPA agreement that was distributed to member agencies for the addition of Chino Valley Fire District and to add





the Apple Valley Fire District to the amendment to the JPA agreement for consideration of each member agency.
